Importation of medical devices for human use must be handled according to the following regulations: (1) A photocopy of the medical devices pre-marketing license or an approval document issued by the Ministry of Health and Welfare should be submitted. In addition, the number of the pre-marketing license (consisting of 14 letters and digits) must be declared and listed in the import declaration . (2) If the medical devices being imported are dangerous, then besides the photocopy of the medical device pre-marketing license and the license number declared and listed in the import declaration, an approval of the medical institutions/facilities procurement from the Ministry of Health and Welfare is also required.</p> <p>2. Importation of medical devices which are not for human use are exempted from the above regulations.</p>
581	Approval from the Atomic Energy Council, Executive Yuan is required.
581*	Approval from the Nuclear Safety Commission is required.
MW0	Importation of Mainland China products is prohibited.
